



# Important - Please read

Your transition to Simmons Bank is fast approaching, and we are happy to be welcoming you into our banking family. A few reminders are detailed below, along with links to important training resources. # ACH Positive Pay (ACH Blocks and Filters)

If you currently have ACH blocks or filters set up on your accounts today, they will map over to Treasury Connect. Any exception items will be presented in Treasury Connect for you to decision to pay or return. If a decision is not made prior to the cutoff of 12:00 p.m., the item will be returned.

#### **Check Positive Pay**

We will map over your issued item file formats; please begin uploading your files Monday, April 11. Any outstanding items will be brought over to Simmons Bank Online Banking, and you will not need to enter or upload the items again.

# Electronic Delivery of Statements and Notices (eStatements)

All account statements, account analysis statements and ACH Notice of Change (NOC) notices will be available to you to view and download in Treasury Connect. You may request to have a paper statement mailed instead of, or in addition to, these eStatements. Paper statements are \$5 per statement cycle beginning August 1, 2023.

### **Recurring Transactions**

Please make note of the schedule and next initiation date of any recurring ACH originations, wire transfers or intrabank transfers prior to April 8. You will need to review and schedule, if necessary, the recurrences for these transactions in our Online Banking system beginning Monday, April 11.

# Remote Deposit Complete

Simmons Bank uses the same Remote Deposit Complete platform that you use today. Your login information will change, as access to Remote Deposit Complete will be

available within Simmons Bank Online Banking.


